Mark Odden brought up recent legislation HF 549 and the current status of the bill. Kathryn Dolter expressed concerns regarding the legislation as it allows for nursing students to administer medications without being a licensed nurse. She is concerned that students who have graduated from nursing school but have not passed the NCELX exam to become a licensed nurse could indefinitely be administering medications while being unlicensed. She also expressed concerns that this would be a major patient safety issue.
