### 655 IAC - Chapter 6 - Scope of Practice

The Iowa Board of Nursing published the notice of intended action (ARC 5172C) for the proposed Iowa Administrative Code (IAC), Chapter 6, Scope of Practice rules on September 10, 2020. The public comment period ended September 29, 2020. Written and verbal comments were received. The rules and comments will be placed on the January 2021 Board meeting agenda for discussion and action.

### Important Reminders About License Renewals

The most frequently asked question received at the Board office is licensees calling to ask where their license wallet card is after they have renewed.

The answer is: **Wallet cards are no longer issued.**

After you have renewed your license, you will receive an email confirmation about the transaction.

Since 7/1/2019, the renewal process no longer includes sending a wallet card. Licensees and/or employers may now verify a license status through the [IBON Online Services](#) portal, by clicking on the [license verification tab](#). The license number is needed to perform the verification. Once entered, the system will provide a

screen with the license number, status, nurse license compact status, license type, original issue date, issue date for the current license and the expiration date of the license. If you want to have a paper document for your wallet or file, there is an option to print a screen shot of the information, *but the information on the printed copy will not reflect any changes to the license should there be any during your licensure period.*

Another frequently asked question is about licensees who have lost their sign-in information and/or their password for access to the IBON Online Services portal. Board staff does not have access to this information. As such, licensees are highly encouraged to keep their Account ID and password in a secure location between renewals. Include your name and license number along with your former address and new address. For name changes, include your complete former name and new name, license number and address.
